2. The purpose and task of studying the discipline "Foreign language (English)"

2.1. The purpose of studying the discipline

The working program was developed taking into account the international practice of language education in universities, the "All-European Recommendations on language education" (ZER, 2001) regarding the levels of language proficiency and the main provisions of the "English language program for professional communication" by the team of authors: G.E. Bakaeva , O.A. Borysenko , I.I. Zuyenok and others. The goal of the course is the formation of professional communicative competence, which allows you to communicate effectively in an academic and professional environment. Studying the discipline "Foregn language (English)" involves not only mastering language knowledge, mastering speaking skills, familiarization with the socio-cultural and pragmatic aspects of English for lawyers, but also the integration of language skills with the content of the "International Law" specialty.
