Description educational component

Work-experiense intership is an integral part of the process of training specialists with a higher education degree «Bachelor» under the educational and professional program «International Law». During work-experiense intership, fundamental concepts about the future profession are established, a system of motivation for learning is formed, and the foundations of professional self-determination are laid. Work-experiense intership of students is the final link of practical training, which makes it possible to deepen theoretical knowledge of disciplines educational plan improve professional competences and raise the level of training. The goal of work-experiense intership is the formation of the professional competence of a bachelor, which is manifested in the readiness to solve professional tasks using theoretical and practical professional and subject knowledge, life experience, values and inclinations, the formation, based on the knowledge obtained at the university, of professional skills and abilities for the adoption of independent decisions during work in specific socio-economic and socio-legal conditions; fostering the need to systematically replenish one's knowledge and creatively apply it in practical activities.

The structure of the educational component

- training;
- informing students about the purpose, tasks and content of work-experiense intership;
- familiarization of students with the procedure of work-experiense intership;
- providing students with instructions on the implementation of the work program of work-experiense intership, the procedure for processing all necessary documents, in particular, the practice diary and the report on the results of the work-experiense intership;
- performance of specific work under the guidance of a work-experiense intership worker from the practice base;
- familiarizing students with the procedure for protecting the production work-experiense intership report.

Prerequisites

Successful study of the disciplines provided by the curriculum of the educational and professional program "International Law".

Post-requisites

The knowledge acquired by students in the course of studying the disciplines provided for in the curriculum of the educational and professional program «International Law» will become the theoretical basis for the formation of a report (after passing work-experiense intership), preparation for the attestation exam in the specialty, the possibility of obtaining a master's degree in the future and carrying out further scientific -research work by specialty.

Evaluation policy

Deadlines and Rescheduling Policy. Reports on work-experiense intership, which are submitted in violation of the deadlines set by the curriculum without valid reasons, are evaluated at a lower grade. A student who has not completed the work-experiense intership program for good reasons may be granted the right to undergo work-experiense intership again if the conditions determined by the university are met.

Academic Integrity Policy. Reports that are mechanically transcribed from regulatory documents, regulations, job duties, unprocessed and not properly formatted, and even more so made by verbatim use of the text and ideas of other authors without reference to relevant sources of information, are not allowed for protection.

Visitation Policy. Visiting the practice bases is a mandatory component of the assessment, for which points are awarded. For objective reasons (for example, quarantine, martial law, illness, internship abroad), the work-experiense intership can take place in an online form upon agreement with the head of the work-experiense intership.

Evaluation system and requirements

The requirements regarding the procedure for passing the work-experiense intership and protecting the report are given in the work-experiense intership program.

The final score (on a 100-point scale) from work-experiense intership is determined as a weighted average, depending on the specific weight of each credit component:
