2.1. Purpose of the study of discipline

The purpose of studying the discipline "Migration processes in international relations" is a study of sources evolution, nature, and factors, common and special characteristics of the process and the results of migration to the European continent and in international relations in general.

8. Training on discipline

Training is the planned process of modifying (changing) the attitude, knowledge or behavioral skills of the learner, by acquiring learning experience in order to achieve effective performance in one type of activity or in a particular field. The order of the training

- 3. Practical part is realized by performing tasks in groups of students on certain issues of the subject of the training session.
- 4. Summing up. The results of the tasks performed in the groups are discussed. Exchange of views on the issues that were put on training sessions.

- 2. Human rights a migrant (refugee).

9. Means of evaluation and methods of demonstrating learning outcomes
