

Cooperation Agreement

Ternopil State Economical University (Ukraine), Faculty of Computer Information Technologies as the first party, and Kaunas University of Technology (Lithuania), Faculty of Informatics and the Faculty of Chemical Technology, as the second party, hereinafter referred to as "The parties", settled the given Cooperation Agreement in the following branches and directions.

Part I Scientific Research Work

1. The parties undertake:

- 1.1. to provide conditions for joint scientific-technical projects fulfillment, carrying out consultations and information exchange in the field of scientific and technical problems, especially in the area of environmental sciences and engineering.
- 1.2. to have constant exchange of materials for being published in the periodicals of both universities.
- 1.3. to introduce the partners and their achievements in the way of exhibitions and printed editions exchange.
- 1.4. to take part in the international scientific projects to exchange experts and projects.

Part II Education Methodology Work

2. The parties undertake:

- 2.1. to provide teaching staff exchange aimed at lecturing, carrying individual researches, participating in scientific conferences.
- 2.2. to provide experience exchange in the field of educational methods, curriculums and programs and in the field of management of education process.
- 2.3. to provide graduate students and special courses students' exchange.

Part III Financial Terms

3. Financing of cooperation is based both on for all parts common projects and on internal sources of the parties.
4. Financial income and usage of the common scientific research results will be dealt by means of exchange between the Parties according to the legal documents valid in every country.

Part IV General Terms

5. This agreement does not have fixed term. Any alterations, amendments or termination can be done only based on the mutual agreement of the parties.
6. This cooperation agreement is signed in English in three original copies that are of the same validity.
7. This agreement comes into force as soon as it is signed by both parties.
8. This agreement provides general guidelines for the cooperation of the parties in the

mentioned areas. More specific agreements concerning the exchange plans on the scientific research projects and education methodology work will be signed between the parties in the future.

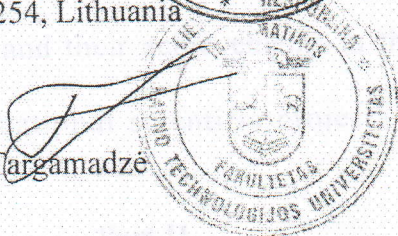
