

AGREEMENT OF COOPERATION
between
Ternopil National Economic University (Ternopil, Ukraine)
and
Jesuit University Ignatianum in Krakow (Poland)

Ternopil National Economic University, represented by the rector, prof. Andriy Krysovaty, acting on the basis of the Statute from one side and the Jesuit University Ignatianum in Krakow represented by the Rector prof. Józef Bremer from the other side agree to stimulate and mutually support cooperative relations, which will emphasize the development of collaborative educational and research projects. Both Parties will encourage direct contact and cooperation between their faculty members according to the provisions of this Agreement.

Hereinafter referred to as the Parties, hereby have agreed as follows:

1. Within the mutually agreed fields of study the Parties agreed upon the following general forms of co-operation:

- 1.1. Modernization and expansion of new educational programmes, education methods.
- 1.2. Participation in the methodological seminars, scientific conferences.
- 1.3. The exchange of academic staff.
- 1.4. The exchange of administrative and professional staff.
- 1.5. The exchange of students.
- 1.6. Joint organization of courses, study tours, conferences and seminars.
- 1.7. Joint research projects.
- 1.8. Other forms of university co-operation of mutual interest.

2. Terms of joint activities, the conditions for utilizing of the results achieved, and arrangements for specific visits, exchange and other forms of cooperation will be negotiated for each specific activity. It is also understood that any financial arrangements will be negotiated and agreed upon in writing for each specific case and will depend on the availability of funds.

Funding can be realized by means of involvement of the financial resources of special funds, programs, grants or sponsors, financial support on the bases of separate contracts.

3. Exchange of academic staff, research staff, annual quotas, conditions of their stay will be defined in a separately prepared working programme. This working programme may be rearranged every three years in accordance with the proposals of the Parties in order to meet new demands and requirements.

4. Students exchange will be regulated by the special agreement and/or the working programme between the institutions.

5. The Parties agreed that medical insurance expenses during the stay will be covered by the participants of the exchange programme. The Parties will encourage all exchange participants to purchase adequate health, accident and travel insurance prior to the start of the exchange at the Host University.

6. This Agreement will become effective upon the date of its signing by the representatives of the two universities and is valid during the term of five years.

7. This Agreement is concluded and signed in 2 (two) languages (Ukrainian and English). Both texts are equally valid.
