Working programme on student exchange between

Ternopil National Economic University and Jesuit University Ignatianum in Krakow

Pursuing the Agreement on Cooperation between Ternopil National Economic University and Jesuit University Ignatianum in Krakow of 8th February 2019, para 4 the parties agree to:

- 1. Organize the exchange of students enrolled in the corresponding programs of Tourism of the first educational cycle at the Bohdan Havrylyshyn Education and Research Institute of International Economic Relations of Ternopil National Economic University and Tourism and Recreation at the Faculty of Philosophy of Jesuit University Ignatianum in Krakow.
- 2. The number of participating exchange students will be not more than 5 (five) for each party for each year.
- 3. The length of the exchange stay at the host university will be one semester.
- 4. The incoming students will participate in the teaching process of the Host University enjoying the same rights and obligations as students immatriculated at the Host University unless general legal regulations deem otherwise.
- 5. The Home University is responsible for recruitment, selection and pre-programme orientation of its candidates for the exchange.
- 6. Nomination letters, application files, and other documents as may be required, of students selected by the Home University will be forwarded to the host University for the final approval at least 60 days before the beginning of the semester of exchange.
- 7. The incoming students will individually choose courses to participate in out of the courses offered to them by the Host University.
- 8. The list of the courses available for incoming students will be published at least 60 days before the beginning of semester.
- 9. The number of ECTS points of courses chosen by the incoming student may not be less than 30.
- 10. The Home University will ensure that outgoing students enjoy a basic knowledge of the language of instruction used at the Host University.
- 11. The Host university will organise an intensive Polish or Ukrainian language course respectively for the incoming students.

- 12. The Home University will ensure that its exchange students have a comprehensive health and accident insurance and visas (if applicable) that are valid throughout their stay at the Host University. The Parties will encourage all exchange participants to purchase adequate health, accident and travel insurance prior to the start of the exchange at the Host University.
- 13. The Host University will not be responsible for the cost of accommodation, living, transportation, visa and any other additional costs. The Host University will not be responsible for any personal expenses, debts, costs of damages incurred for the duration of the exchange, and any other costs incurred or arising from this Agreement. The Host University will not be held responsible for any accidents, diseases, damages or other cost-related events which may occur in relation to the Agreement. The Home University will inform their exchange students about this disclaimer.
- 14. This Agreement does not entail any mutual financial obligations of the Parties. Should any of the Parties wish to undertake any action involving financial obligations, it shall only be possible subject to the approval of the authorized representatives of both Parties in this regard.
- 15. This Working programme is valid for three full cycles of exchange and may be changed by the mutual agreement in any time during its validity. The binding changes have to take a written form.
- 16. This Working programme is concluded and signed in 2 (two) languages (Ukrainian and English). Both texts are equally valid.
