Girne American University, represented by Director of Multicultural Summer School Orhan Hasanoglu on the one hand, and Ternopil National Economic University (Ukraine), represented by the Vice-Rector for International and Information Activities Oleh Adamiv, on the other hand (hereinafter referred to as Parties), have concluded this Agreement to establish the mutually beneficial and long-term partnership relations.

1. SUBJECT OF THE AGREEMENT

1.1. The subject of the Agreement is aimed at cooperation in the research, scientific, teaching, methodical, organizational, cultural and educational spheres on the principles of partnership and equality; formation of the single European Higher Education Area.

2. PURPOSE OF THE AGREEMENT

2.1. The Agreement is concluded to promote the development of education and science based on the achievements of the leading local and international schools, and to improve the efficiency and quality of research, methodical, teaching and other activities of the Parties.

3. DIRECTIONS OF COOPERATION

- 3.1. Cooperation between the Parties shall be conducted under the following directions:
- 3.1.1. Research and scientific sphere:
- implementation of the joint research and development projects;
- organizing and coordinating the implementation of the joint scientific papers and grants;
- holding the joint scientific, practical and scientific-methodical conferences, symposia, congresses, seminars and other academic activities;
 - joint participation in the international scientific and educational programs;
- organization and implementation of the reciprocal training, tuition, advanced training of the academic staff of the Parties;
 - mutual exchange of the information on the research and educational programs.
 - 3.1.2. Teaching and methodical sphere:

Let

- assistance in the development of the trends of the research work in the sphere of education:
- organization and participation in the programs of the bilateral and multilateral exchange of students, postgraduates, research and academic staff;
- mutual reviewing of the research papers, theses, final qualifying works, teaching materials, manuals, books, articles, reports and other publications;
- development and implementation of new educational technologies, training courses and programs;
 - interchange of the teaching, research materials, bibliographic and reference literature;
 - exchange of information and consultation services.

3.1.3. Socio-cultural sphere:

- exchange of experience in the field of social protection of academic staff, postgraduates and students;
 - initiating projects in the sphere of tourism and organization of the cultural events;
 - organization of the joint exhibitions and expositions.

4. RIGHTS AND DUTIES OF THE PARTIES

4.1. The Parties are entitled to:

- initiate the organization and realization of the scientific, educational and socio-cultural projects;
- inform on the activities of each of the Parties, directly related to the subject matter of this Agreement;
 - initiate amendments and supplements to this Agreement.

4.2. The Parties are obliged to:

- inform each other about the organization and conducting of the joint activities: scientific, methodical and practical conferences, educational and methodological seminars and other activities under the subject of this Agreement;
 - consult each other on the organization and conducting of the joint activities;
- select candidates for participation in the joint projects and inform them of the terms of participation in these activities;
- inform each other about the problems that arise during the implementation of this Agreement, and find the ways to resolve them under the law;
 - fulfill the terms stipulated by the Agreement.

5. TERMS OF JOINT ACTIVITIES IMPLEMENTATION AND PROVISION

- 5.1. Under this Agreement the research activity is carried out using the facilities and equipment technology available to the Parties.
- 5.2. The results of the scientific activities received under this Agreement, are the common intellectual property. The Parties have equal priority for the use of the results of the joint research activities. The results of the joint research activities under this Agreement are issued as publications of authors' collectives.

6. TERMS OF THE AGREEMENT

- 6.1. This Agreement is done in Ukrainian and English in four copies having equal juridical validity.
- 6.2. This Agreement shall enter into force upon signature of the Parties. This Agreement is perpetual. In case of necessity to terminate this Agreement at the initiative of one of the Parties the other Party shall be informed about such intention by 30 (thirty) days notice.
- 6.3. By the mutual consent of the Parties this Agreement may be amended and supplemented in writing.
